

FY 2025 HIGHLIGHTS

FUNDRAISING & FINANCING

- Provided **\$7,123,000** in funding for construction of **115 new homes** through **Colorado Division of Housing**
- Distributed **\$125,000** in down payment assistance and over **\$140,000** for home repair grants through **Federal Home Loan Bank Topeka** and our financial banking partners; **ANB Bank, Colorado Credit Union** and **FirstBank**
- Facilitated **\$7.1 million** in mortgage sales through partnerships with **FirstBank** and **Colorado Housing and Finance Authority**
- Renewed statewide product donations from **Bryant Colorado**, providing **56** new, energy-efficient furnaces totaling more than **\$77,000** in donated product
- Partnered with the **Colorado Roofing Association** and it's members to install **32** roofs with product donated by **GAF**, saving **\$352,000**

TRAINING & TECHNICAL ASSISTANCE

- Offered **8** virtual trainings **supporting affiliate operations**
- Hosted **10** affiliate networking meetings, engaging **50+** participants from **30** affiliates
- Supported affiliates through **33 in-person visits** with staff and board across Colorado
- Provided customized one-on-one technical assistance logging over **424 hours of support**

REGIONAL CONFERENCE: CAMP COLORADO

- Hosted **38 affiliates from 7 surrounding states** for three days of learning, networking, and celebrating housing innovation
- Offered **45** unique workshop trainings to **260** conference attendees
- Held a 2-day pre-conference **Executive Director Retreat** for **31 Habitat leaders**
- Engaged **28 sponsors and exhibitors** as Camp Colorado partners

FY 2025 HIGHLIGHTS

ADVOCACY

- Issued formal positions on **9 bills** and tracked an additional **11 bills** throughout legislative session
- Hosted our most successful **Coffee at the Capitol** to date- served over **245 cups of coffee**, met with more than **40 legislators**, including **Governor Polis**, and staff from the **Division of Housing**
- Coordinated a **build day** for the **Division of Housing** staff in September with **Fort Collins Habitat for Humanity**



REVOLVING LOAN FUND

- Increased HFHC's Revolving Loan fund to **\$8.3 million** with the addition of a **\$5 million** grant from the **Colorado Division of Housing**
- Provided **\$6.9 million** in loans to **8 affiliates** for the construction of **42** affordable for-sale homes

- Distributed **\$25,000** in total to our tithe partners: **Habitat Cambodia, Habitat Romania, Hábitat Paraguay, and Habitat Ethiopia**
